Hawaii: Submit a letter verifying the person is homeless along with application. <u>Here is an example letter</u>. (Must be a HI agency.)

*Illinois: <u>Complete this form</u> and print it on agency letterhead to apply for a free BC. Must be an Illinois agency applying. If the person is born in Cook County, use this <u>application</u> instead. Can apply outside of Illinois.

Maryland: Individual completes the BC application and the shelter submits a letter to accompany that. The shelter must be in Maryland.

Michigan: Apply for birth certificate and send check. Then we can apply for reimbursement through <u>this form.</u>

***Nevada:** Complete <u>this application</u> and submit the required documents to prove identity. Application must be sent to Carson City.

***New Jersey:** More information available through <u>this link</u>. Include a work ID, a letter of request on a letterhead from the shelter, complete the <u>application form</u> and send it to the state office. The Vital record will be mailed to the address on the letterhead (business address).

***New Mexico:** Submit <u>"HOMELESS SELF-ATTESTATION FORM"</u> along with standard application and identification requirements.

Oregon: Must apply through a participating organization in Oregon. <u>See this list</u> to find an organization in the county they were born in.
